1 SCHEDULE A TERM

The term of this Schedule A will be 24 months beginning January 1, 2024 (the "Initial Term"). Following the Initial Term, this Schedule A shall automatically renew for additional periods of twelve (12) months (each one, a "Renewal Term"), unless written notice of termination is provided to either party at least sixty (60) days prior to the expiration of the Initial Term or any Renewal Term. In the event an existing Bridger Insight Customer already has in place, prior to the first day of the Initial Term hereof, a EULA or written license agreement for Bridger Insight which is herein superseded, a prorated amount of the license fees already paid by Customer under such agreement applicable to the period following the first day of the Initial Term hereof shall be applied to the amount due hereunder for the Initial Term.

2 APPLICABLE USE CASE

2..1 Customer acknowledges and agrees that it will use the LN Services herein only for the following purpose: Anti-Money Laundering.

3 BRIDGER INSIGHT FEES

- **3.1 Bridger Insight Annual License Fee:** Customer shall pay to LN each 12-month period ("Year") beginning on the effective date hereof an annual license fee of €3,392.66 ("Bridger Insight Annual Ucense Fee") in exchange for the license to monitor up to ... ("Bridger Insight Annual Usage Maximum") using Bridger Insight XG Service. Customer shall not exceed the Bridger Insight Annual Usage Maximum in a given Year except upon LN's prior written agreement and payment to LN of the additional applicable fees. - **4.2** The WCO Annual License Fee is independent of (and therefore not subject to offset by payments in excess of) any other fee. WorldCompliance services are provided by World Compliance Ine.
- 4.3 WorldCompliance Data Segments: Customer shall have access to All Segments.
- **4.4 WorldCompliance Online Search Tool Complimentary Access:** Customer shall be provided one (1) complimentary User 1D for use of the WorldCompliance Online Search Tool services at no charge. WorldCompliance Online Search Tool is hosted on a LexisNexis US server.
