

**Full wording
of Decree of the Ministry of Finance of the Slovak Republic
No. 413/2001 Coll.
of 2 October 2001**

**to implement
Act on Compulsory Contractual Motor Vehicle Third Party Liability Insurance
and on amendments and supplements of certain laws as amended by
Decree No. 569/2004 Coll.**

In accordance with Article 11 paragraph (1) and Article 16 paragraph (4) of Act No. 381/2001 Coll. on Compulsory Contractual Motor Vehicle Third Party Liability Insurance and on amendments and supplements of certain laws (hereinafter referred to as the "Act") the Ministry of Finance of the Slovak Republic lays down as follows:

Article 1

(1) The certificate of the compulsory contractual motor vehicle third party liability insurance (hereinafter referred to as the "liability insurance" shall contain the following information:

- a) number of the liability insurance certificate consisting of an insurer special numerical combination,
- b) name, surname and permanent or long-term residence of the motor vehicle owner or the name and registered office of the motor vehicle owner in accordance with the motor vehicle papers in case that the motor vehicle is subject to the motor vehicle registration,
- c) name, surname and permanent or long-term residence of the motor vehicle owner or the name and registered office of the motor vehicle owner in case that the motor vehicle is not subject to the motor vehicle registration,
- d) personal identification number or identification number of the person under subparagraph (b) or (c); where the personal identification number has not been assigned to a natural person, the date of his/her birth shall be stated,
- e) commercial name of the insurer and its registered office,
- f) period of liability insurance validity,
- g) kind of the motor vehicle, brand of the motor vehicle and its type,
- h) Vehicle Identification Number; if not assigned, the number of the motor vehicle body or chassis,
- i) motor vehicle licence number,
- j) series and number of vehicle registration papers or a similar document,
- k) date of issue of the liability insurance certificate, the signature of a person authorized to act on behalf of the insurer and the stamp of the insurer.

(2) The specimen liability insurance certificate is given below in Annex 1. The certificate shall be of white colour and sized 95 x 70 mm.

(3) Where a special licence number has been assigned to the motor vehicle,¹⁾ the data under paragraph (1) subparagraphs (g), (h) and (j) shall not be stated in the liability insurance certificate.

Article 2

(1) The certificate of the insurance of liability for damages caused by a foreign motor vehicle in the territory of the Slovak Republic and in the territory of another Member State of the European Union shall contain the following information:

- a) number of an insurance contract,
- b) registered office of the Slovak Insurers' Bureau,
- c) name and surname, permanent or long-term residence, the state of the permanent or long-term residence, date of birth and the passport number of a policyholder and the country in which the passport has been issued,
- d) name and surname, permanent or long-term residence, the state of the permanent or long-term residence of a natural person being the owner of the motor vehicle, or the name, address and state of the registered office of a legal person being the owner of the motor vehicle,
- e) kind of the motor vehicle, its brand and type,
- f) motor vehicle licence number and the international mark distinguishing the country of the motor vehicle registration,
- g) Vehicle Identification Number; if not assigned, the number of the motor vehicle body or chassis,
- h) engine power and cylinder capacity and the total weight of the motor vehicle,
- i) period of liability insurance validity,
- j) premium volume and the date of payment,
- k) stamp, date and signature of a person authorized to act on behalf of the Slovak Insurers' Bureau,
- l) signature of a policyholder.

(2) The specimen certificate under paragraph (1) is provided in Annex 2.

Article 3

This Decree shall come into effect on the date of its publication in the Collection of Laws of the Slovak Republic.

The Decree No. 569/2004 Coll. has come into effect on 1 November 2004.
