# Full text of Decree of the National Bank of Slovakia <br> of 26 October 2001

#### Abstract

stipulating detailed conditions on which businesses may process banknotes and coins for other persons, and the procedure for banks and businesses in processing banknotes and coins, as amended by the Decree No. 607/2008 Coll.


Pursuant to Article 17h (2)(g) of the Act of the National Council of the Slovak Republic No. 566/1992 Coll. on the National Bank of Slovakia, as amended (hereinafter the "Act"), and under Article 4 (11) of the Act No. 659/2007 Coll. on the introduction of the euro currency in the Slovak Republic, and on amendments to certain laws, the National Bank of Slovakia stipulates as follows:

## Article 3

(1) Banks and branches of foreign banks and entrepreneurs that obtained a prior permission from the National Bank of Slovakia to process banknotes and coins for other persons shall classify the Slovak banknotes and the Slovak coins (hereinafter the "Banknotes and Coins") according to their denominations and genuineness in
a) genuine banknotes and coins that are further classified according to their quality in

1. banknotes and coins fit for use in circulation;
2. banknotes and coins unfit for use in circulation as being worn out by circulation or damaged;
b) counterfeit banknotes and coins, or altered banknotes and coins, or banknotes and coins suspected of being counterfeit or altered.
(2) The entities listed in paragraph 1 shall pack the banknotes and coins according to their number and individual denominations as follows:
a) banknotes of the same denomination are placed in packets of 100 banknotes which are banded; the banknotes are put into the packets smooth and aligned to sides and print orientation; ten full packets of banknotes of the same denomination represent a bundle of euro banknotes;
b) coins of the same denomination are placed in bags or rolls, and the bags or rolls with coins are then packed in coin bags or polyethylene film containing the quantity specified in the Annex.
(3) Bands used for banding the banknote packets, and the bags, rolls or coin bags, and polyethylene film with coins shall always indicate the quantity of banknotes and coins contained therein, their denomination and total amount, business name (name), and place of the competent organization unit of the handling entity listed in paragraph 1 ; in delivering and receiving the banknotes and coins, there shall be a list specifying the quantity and the sums of the individual denominations of the banknotes and coins, and the total amount of the packaged banknotes and coins.
(4) Unfit banknotes and coins shall be delivered in accordance with paragraph 1 in packets (bundles) of such banknotes, and in bags or rolls of such coins, marked with the text "Unfit cash" or with the large bold letter "N". Damaged banknotes and coins, if complete, shall be placed in the packets of banknotes, bags or rolls of coins worn out by circulation.

## Article 4

This Decree shall become effective as at 1 December 2001.
The Decree No. 607/2008 Coll. became effective as at 1 January 2009.
